DO NOT TAKE ANY medicines containing aspirin such as Bufferin, Anacin, Excedrin, Alka-Seltzer, Empirin, Darvon compound, and all medications containing Salicylates, like Pepto Bismol. Tell every doctor you consult that you are allergic to all <u>sulfa drugs</u>, drugs with <u>Tartrazine</u> and <u>Salycilates</u>.

CHECK ALL LABELS of prepared foods or drugs for artificial flavorings. STOP USING perfumes.

## A Word of Explanation

Modern dyes, chemically known as *azo dyes*, are related to the natural salycilates, such as the distilled willow bark that American Indians used for treating headache and other pains, and with which they dyed their clothing.

In 1939 researchers discovered that an azo dye, Protonsil, would also kill bacteria. This dye became the first *sulfa drug*, so called because the chemical companies figured people would rather be treated with a drug than with a dye. Today, allergies to sulfa drugs and to aspirin are widely attested. German physicians documented so many allergic reactions to dyes in the early part of this century that today fewer than 20 chemical substances are approved for use in European food chemistry; the American food industry uses more than 50,000 food chemicals none of which have been tested for their interactions with each other or in living systems..

In the 1950's Stephen Lockey, M.D. of Lancaster, Pennsylvania, pioneered work in the United States with the effect of food and drug additives on human beings. He documentied allergies to food dyes and other chemicals which are related to the salycilates, to aspirin and to sulfa drugs. He found hives (urticaria), among others, a common symptom in reaction to the salycilate family.

Many medicines contain dyes for no seeming good purpose except to be visually distinctive. Mycostatin, for example is a deep purple and it is a bright yellow (Tartrazine) inside. Be aware that when you are hypersensitive your well-being can be devastated by chemicals in your food and in your medicine.
